Rules for the Draw

- 7 Draws will take place monthly and the names of the winners published in Ibis Link, on Prudential Group noticeboards and on the relevant intranets. All winners will be notified by telephone and confirmed by post
- 8 Prizes shall only be awarded to the person to whom the winning share was sold and are non-negotiable
- 9 The winners are drawn every month with a star prize being drawn every quarter
- 10 Draws shall consist of a random selection of shares from all share numbers allocated to members which are still current
